 - A. Public Comment

Mr. Chase made the motion to allow Ms. Rice to speak. Seconded by Mr. Belanger Vote-5-0

Ms. Rice, a Nurse in Public Health, speaking on behalf of her mother, Mrs. Elliott, an abutter to property on Somerset Street that is raising farm animals in a neighborhood setting. She spoke of concerns regarding health and environment issues related to proximity to this atmosphere. She encouraged the Board to contact health officer, local and state health officials, resources and departments regarding the negative effects of proximity to farm animals, in a neighborhood setting, etc. She would also, suggest an ordinance prohibiting this practice.

Mr. Richard spoke concerning the property in question. He owns the property and spoke of the great lengths taken to assure cleanliness and utmost care of the property and the animals, as well as, any waste products, etc. in relation to care and cleanliness. These animal arrive in April and leave in October, as part of a 4-H program. He spoke of his exasperation with this situation. He explained they have taken every step and precaution to assure the neighborhood would not be effected He expressed his angst with the situation. He explained the animals are properly vaccinated, tagged, state inspected, insured, etc. Proper record keeping/paperwork... State Health, Local Health Office, Animal Control Officer, Code Enforcement Officer and the Rumford Police Department have all been to the property and found nothing wrong; every inspection has been passed. He feels he is being harassed by the neighbors, with no evidence of wrong doing.

Sue Billings from the USDA and the Extension Office spoke on Mr. Richard's behalf. She expressed that she would be happy to answer any questions. 4-H does fall under the umbrella of the Maine Agricultural Act, which is covered under Federal Law- guidelines and requirements...

Ms. Kouin spoke about the harassment from the neighbors and how it is affecting her 11 year old son who is responsible for the care of the animals. She is trying, thru this 4-H program, to teach her son responsibility, integrity, etc. He is being traumatized by neighbors approaching him when no parent is home, etc. She said DDHS has called checking the children's health and wellbeing. She asked that folks approach her and her husband, not her 11 year old son.

Ms. Rice again spoke of property values and reassessment of properties with having these farm animals in the neighborhood.

Mr. Chase expressed nothing the Select Board can do concerning this issue and need to move on.
