TO: Thomas Bourret, Constable of the Town of Rumford, in said County.

GREETINGS:


In the Name of the State of Maine, you are hereby required to notify and warn the Inhabitants of the Town of Rumford, qualified by law to vote in Town Affairs, to assemble in the River Valley Auditorium located in the Rumford Municipal Building, 145 Congress Street, in said Town, on the 9th day of October, 2018 AD at six o'clock in the evening for a special town business meeting to act on the following article, to wit:

ARTICLE 1. To see if the Town will vote to authorize and ratify the acts of the Board of Selectpersons to negotiate the terms of sale, and to sell and convey, the land owned by the Town of Rumford located on the southerly side of Route 108 in the Town of Rumford, which land is identified on Tax Map 131 as Lot 12 and Tax Map 134 as Lot 1, and which land is more particularly described in a Deed dated November 6, 2003 from Thomas L. Dickson, Jr. to the Inhabitants of the Municipality of Rumford which has been recorded in the Oxford County (East) Registry of Deeds in Book 3414 at Page 152, said property including all of the Puiia Business Park, in addition to another parcel obtained via the same above-described deed, all upon such terms and conditions as the Board of Selectpersons shall determine to be in the best interest of the Town.




