There were no requests presented.

- 4. Reports
 - A. Selectperson's Report

Ms. Lovejoy commented on an article in the newspaper regarding two Mountain Valley High School students who belong to a group of students that have tackled issues such as sportsmanship with other students from across the State and commended their efforts.

Mr. Sterling spoke about when he joined the Board of Selectpersons with a desire to help change the atmosphere or mood of the political tone. He believes this Board has done a pretty good job and helped create a better climate for business attraction. He believes the Annual Business Meeting will not spoil this, but was disappointed discussion on all warrant articles was cut off. He reflected about the budget process and the public concerns that have been expressed. He also spoke of enjoying working with Brad Adley on the Board.

Mr. Adley reported attending Mountain Valley High School's graduation and commended them. He was disappointed in the attack on the Board at the Annual Business Meeting.

B. Town Manager's Report

The Town Manager reported that WVAC will not be present tonight as they were committed to Mountain Valley High School.

The demolition impact studies for 426 and 428 Waldo Street are in progress and we should receive the results back in a few weeks.

The Tractor Supply Store will have a ribbon cutting on June 22 at 8:00 a.m.

The Town Manager attended the Maine Downtown Center Annual Conference to be present when Envision Rumford was recognized as only one of two towns to be accepted as a Maine Downtown Networking Community.

The Park and Recreation Department will be replacing the flag pole in Veteran's Park and will be making a recommendation to the Board at the next meeting.

Board of Selectperson's Meeting 06 06 2013

The July 4th Committee will be holding their next meeting on Tuesday, June 18, 2013 at 6:00 p.m. in the Conference Room. Volunteers are needed and welcome.

At the last meeting there was information requested on the Town's streetlights. The average cost per light is \$161.00 annually and the total annual cost for all streetlights is \$122,000.00. We removed 36 streetlights that saved \$5,800.00 a year and negotiated a new electricity rate with a total savings of \$8,740 a year. Any new street light has a 15 year commitment. Citizens can take over the cost of streetlight for approximately \$15.00 per month. Information was also requested regarding if there was any increase in crime due to the removal of the streetlights. No statistics were available, however, safety concerns have been raised as there are some entry points onto roads or areas with less or insufficient lighting.

Dog owners were encouraged to be responsible for cleaning up dog waste when walking their dogs.

Citizens were also reminded to Reuse, Reduce and Recycle.

C. Department Manager's Report

There were no Department Manager's Reports presented.

Ms. Lovejoy made a motion to support the Code Enforcement Officer and to allow him to proceed to the next level of action. Vote: 3-0

Eric Davis asked about where the codes came from and if they have enforcement action written in them. He was informed that the codes currently being enforced were adopted by a vote of the citizens.
