BOARD OF SELECTPERSON'S PUBLIC HEARING FOR ORDINANCE REQUESTS AND CHARTER AMENDMENTS FOR NOVEMBER 2018 July 19, 2018 5:30 p.m. Rumford Falls Auditorium

2. Public Hearing for Ordinance Requests and Charter Amendments. Article IV

Ordinance Request- Mitzi Sequoia- Clear guidelines for in Town bon fires with relation to unattended fires, curfew restrictions, safety, proximity to other homes/properties, regulations, etc.

- Ms. Sequoia explained the reason and purpose for her request.
- Mr. Brennick asked Chief Reed to speak. Chief Reed expressed a policy issue.
- Mr. Chase expressed his experience and process of building, maintaining and containing a bon fire with responsibility.
- Mr. Belanger expressed concerns of setting stringent rules as many people enjoy the comfort of a bon fire without issue.

No Action

21-B Curbside Recycling and Curbside Waste

- Mr. Brennick asked CEO, Mr. Coulombe to explain the ordinance. Only change, removing "leaves" from this ordinance
- Mr. Belanger expressed adding verbiage that would prohibit leaves raked to streets/ road sides.

Town Manager agreed an expressed adding verbiage similar to snow removal policy/ ordinance.

Town Attorney explained the process/ procedure of ordinance requests, etc. and the process for final approval.

- Mr. Buccina, NORSWB Board spoke of education in schools concerning recycling, etc.
- Mr. Chase requested clarifications for the entire process/ procedure.

Town Attorney expressed Charter verbiage clarifying the process/ procedure for hearings on this topic

Action

25-E Vacant/ Abandoned Buildings

Removing the word "abandoned" from this ordinance

Mr. Belanger asked for clarification on the change/removal of verbiage.

Town Attorney explained the reason for the change being, citizen's confusion and offense.

Mr. Brennick addressed formatting issues; suggested consistency in formatting.

25-H Rental Premises Health and Safety

Regulation of Health and Safety of Rental Properties

Mr. Barnett addressed concerns with this ordinance. He asked for ongoing conversations with Landlord Association and guidelines that work for everybody'd safety without the loss of needed housing.

Attorney Mr. Austin (not a landlord, but a citizen of and business owner in Rumford) addressed some of what he feels are, major flaws in the ordinance. Example #1, Section 6-27 "Findings"- pertaining to, dilapidated dwellings, assuming the ordinance being directed to section 8 housing...He expressed rules and regulations from Maine State Housing Authority, Subject to-Federal Law/ rules regarding Housing and Urban Development requirements. Questioned "Findings" report that specifically notes location of said buildings, assessment and tax records. Example #2 Section 6-28- "Scope"- exemptions to proposal. Section 5- "Violations"- fines and authority of CEO questions. Expressed concerns regarding to ordinance enforceability and impracticability of the proposal. Section 6-46 "Building Inspection"- CEO responsibility for the entire administration and discretion; much power to one person. \$50.00 fee per unit/per annually, for inspection; origin of the fee? Section 6-49-"Isuance of Order to Correct Violations"-6-50- "Evacuation Posting of Unfit Premises"- Very serious business. ? Responsibility of the Town of Rumford, along with expense. 6-54- "Condemnation and Demolition of Dangerous Buildings"- Aggrieved by the Board of Selectperson's: incorrect information in paragraph; Court does not take order/direction/ appeals by a municipal Select Board; Rules of Court are established by the Supreme Court. Section 6-71-"Occupation Requirements" - doesn't make sense. 6-83-"Design Standards for Manufactured Housing"- ADA requirements... Attorney Austin stated his strong lack of support for this ordinance.

Mr. Chase expressed concern regarding need for authority for CEO; protection of tenants, etc. Suggested putting an ADHOC group or committee together to represent Select Board Landlords, Fire Chief, Citizens, CEO; create a document compensable/ equitable to all concerned.

Mr. Brennick made the motion to allow Mr. Burgess, a non-resident, an elected official for Landlord Association to address the Board. Seconded by Mr. Chase Vote-5-0

Group named: Maine Apartment Owners and Managers Association. Lobby for Laws throughout the State for protection of landlords and tenants regarding health and safety, inspection requirements, codes, plan of action for corrections, etc. "We already have this in place. Why are we wasting time doing it again?"

Mr. Burgess Contact person for landlords

Mr. Pearson a landlord in the area reiterated and expressed many concerns regarding policies, etc. Consistency in requirements and inspection process. ADA compliance astronomically expensive and landlords will go out of business.

Mr. Brennick expressed his support of creating a document more viable for everybody concerned, in working with an ADHOC group.

Mr. Muse, landlord, expressed concerns and exasperation with the outrages proposal of this ordinance

Mr. Brennick made the motion to allow Mr. Ziko, a non-resident, landlord to address the Board. Seconded by Mr. Chase.

Vote-5-0

Mr. Ziko, landlords, expressed his concerns and his exasperation with the outrages proposal of this ordinance.

Several upset and angry landlords addressed the Board concerning this ordinance. All addressed the Board and spoke of their concerns, etc.

- A. Public Comment None
- B. Town Manager's Report
- Sent representative to the roll out of the results from the broadband planning grant.
 Rumford is in a unique position and will be looking for funding opportunities to expand broadband to other locations in town
- Attended Rotary's President Transition Dinner where we presented outgoing President Randy Therrien the Spirit of America award
- Attended Forest Opportunity Roadmap (FOR) Maine workshop looking for ways in which to expand the products available through research and development for wood
- Met with the USDA for discussion of grant opportunities with regard to the Meeting House and the K9 vehicle. We are not eligible for their grant program and are unlikely to score high enough for a loan. *See explanation below
- Multiple conversations with Axiom concerning the broadband project
- Conference call with Portland City Manager and Director responsible for the placement of individual from the shelters. Explained our position and asked for continued conversation when looking to relocate folks to Rumford that will ensure we have the resources for them
- Attended Opioid Partnerships in Action Seminar, facilitated by Anne Haslett, USDA
 Assistant to the Secretary. I engaged her in a one on one conversation about Rumford
 and the importance of the emphasis on fighting the drug problem facing rural Maine and
 specifically Rumford
- Traveled to Portland for a legal matter
- Hosted the organization that runs the broadband grant program, Connect ME, in our auditorium
- Identified there is money available through USDA for broadband. This fund does not consider the formula used for other USDA programs outlined below

- Met with Randy Chicoine and Scott Reed from ND Paper. We discussed preliminary projects that they are in the process of planning. I will say this is an exciting time and will share more as things become more focused
- Met with Mia Purcell and Mark Ouellette on broadband project
- Met with folks from the Maine Preservation Society—they expressed interest in the duplex in the brick park as well as the Pillsbury Clough building and intend to submit a proposal to you as early as next meeting
- Met with a commercial appraiser to evaluate the business park for potential development
- Met with attorney for the bond bank on the \$1.379Mil loan in anticipation of a month end closing
- Met with contractor working to solve the water issues and damage to the ceiling and clock tower
- Discussed options to move the tax acquired property, at this point we are exploring working with an auctioneer

DOWNTOWN PROJECT

- Our inspector is on site. He is available in the temporary office where Poland Spring is located as well as on the project. His name is Gary Violette.
- The crews begin temporary water service installation next week. You may have seen the trenching for it as that began today
- Work on the drainage system next week on Hartford and Congress
- Fine grading will be done on River, Hartford and Exchange in preparation for paving which should begin next Friday
- The following week work begins on the curbing and walkways River/ Exchange and I owell
- Sewer lines on Congress will begin and are expected to take two weeks

Much discussion has taken place concerning broadband and natural gas project. We have limited resources and have prioritized the project to ensure the entire Island is served by broadband. As a result of the limited funds and lead-time for ordering the pipes for natural gas it appears we will not be able to bring it to the entire Island.

However, I have made calls today and I am now more hopeful, we can make it work in a modified fashion, but, won't know if that is the case until tomorrow.

I am as disappointed as everyone else who has heard this story, however, from the beginning of the project, we told you all, the gas and broadband will not hold up the project or be the reason the contractor would have to remobilize next spring.

Chief Reed advised the Board of his plan to solicit Bids for the replacement of the Command Vehicle.

Town Clerk, Ms. Bellegarde expressed concerns from the last meeting (listened to Audio recording) and the election. Explained the process before and after the election as well as, the integrity of the process,

procedures and staff. She elaborated on State of Maine Law regarding elections and recounts for a referendum ballot. She explained specific training regarding elections. Duties of the Town Clerk, Warden and Moderator. Dispelled rumor and innuendo surrounding the lection and her office. Variation was less than 6=.4000% error. Explained the entire recount process to the Board.
