Town Manager Report 11/2/17

- Attended I+I (inflows and Infiltration) meeting at the Waste Water Treatment plant where we discussed the storm water infiltration from the Island and its effect on the treatment system
- Attended LD 756 Celebration at Rumford Power/Emera Energy- this legislation allows for the company to produce and distribute in the same area
- Attended the community Pot Luck dinner in Rumford Center where the discussion topic was all about traffic—I informed the group, the town has requested DOT to perform an assessment of the area for both speed and safety. Addressed concerns of enforcement. We also asked DOT for improved signage
