7:06 pm Mr. Brennick presented Spirit of America Award to Dennis and Druscilla Breton; a framed proclamation and an engraved desk clock, as a gift from the Town.

Senator Lisa Kiem gave a brief welcome and presentation, providing contact information for herself. She spoke on the work being done in this legislative session with approx. 3000 bills submitted before the legislature, working on the budget, revenue sharing, increasing homestead exemption, unclaimed property and issues that affect rural Maine.

**ARTICLE 1.** To choose a Moderator to preside over said meeting and serve pursuant to ARTICLE XII of the Town Charter.

Town Clerk/Treasurer asked for nominations for Moderator

One nomination and four ballots cast for Rob Cameron; sworn in at 7:17pm necessary paperwork signed by Town Clerk/Treasurer and Moderator

Moderator explained rules, policy and procedure for Annual Town Business Meeting and voting. He then asked the audience if there were any questions.

**ARTICLE 2.** To see if the Town will vote to accept the report of the Municipal Officers of said Town for year ending June 30, 2019. 2018.

Discussion-Incorrect year, corrected Motion-CB, PC Vote-Pass

**ARTICLE 3.** To see if the Town will vote to collect taxes on a semi-annual basis and allow the Board of Selectpersons to determine the dates of collection based on the Town's ability to set the tax rate.

Motion- PC, CB Vote-Pass

Recommended by the Finance Committee that the Town collect taxes on a semi-annual basis, with the due dates to be determined by the Board of Selectpersons, based on the Town's ability to set the tax rate.

**ARTICLE 4.** To see if the Town will vote to charge interest on all taxes on a semi-annual basis, until revoked, and to see if the Town will vote to charge interest on all taxes unpaid after a specified time; and to set an amount of interest it will pay on over payment of taxes.

Mr. Gary Dolloff came to the microphone to ask a question, "How did this project go so far over budget"?

Interim Town Manager responded- Many factors have led to where the project is now, estimates were low. He explained, the project was not designed properly with specifics or executed properly.

Mr. Dolloff asked, what happens if Article 10 fails?

Interim Town Manager responded-The project would be left as is; stabilized for safety and use. No good answers...many issues still remain from other sources... He expressed, the funds are needed to properly complete the project.

Mr. Chase went on to say that, inaccurate estimates and poor planning were also issues with the project.

(\*The total principal amount of authorized issuance is \$2,900,000, which may be financed through the Maine Municipal Bond Bank's State Revolving Loan Funds or other loan programs or financial institutions and may include a certain amount eligible for principal forgiveness conditioned upon compliance with certain Maine Department of Environmental Protection and State Revolving Loan Fund requirements. Accordingly, the total estimated debt service is \$4,612,521, of which principal is \$2,900,000 and estimated interest at an estimated interest rate of 3.3%, over 30 years is \$1,712,521).

The Select Board recommends a "yes" vote.

When money is borrowed by issuing bonds, the Town must repay not only the principal amount of the bonds but also interest on the bonds. The amount of interest to be paid will vary depending upon the rate of interest and the years to maturity at the time of issue. The validity of the bonds and of the voters' ratification of the bonds may not be affected by any errors in the estimates made of the costs involved, including varying interest rates, the estimated cost of interest on the bond amount to be issued and the total cost of principal and interest to be paid at maturity.

# APPROVAL OF GRANT REQUEST

ARTICLE 24. Shall the Town vote to authorize the Select Board to apply, on behalf of the Town, for State grant assistance under the provisions of the Boating Facility Fund, Title 12 M.R.S. §§ 1896 and 1899, for the Town Boat Launch Improvements and to further authorize the Select Board or its designee to enter into the Boating Facility Fund Project Agreement with the State subsequent to the approval of the project and to further appropriate the sum of \$50,000 from an existing Capital Reserve Account, as local share matching funds, and to further authorize the Select Board to expend funds from the Town's undesignated balance of the General Fund as needed to pay for the entire project while awaiting State reimbursement for the State's portion of the project.

**Explanation:** The existing boat landing is deteriorating significantly and the landing is also located in an upriver setting which is nearly unnavigable. Obtaining this grant will allow the Town to install a new landing downriver, including an ADA Compliant floating dock. The voters need to approve expenditure of these funds for the purpose of improving the boat launch site, providing boat access to the Androscoggin River off Route 2, in Rumford. If approved, the project is expected to be underway in the fall of 2020.
