- b. Town Manager's Report

Carter stated that the Poland Springs Committee met and made awards to Old School Food Pantry for \$5,000, Western Foothills Kids Association \$5,000 and American Legion for \$7,500. Carter noted that they should have the budget ready for the Fire Department project. He noted they are looking at how we have handled citizen voting on previous bonds and borrowing it has been done at the Town meeting and not by ballot. Bond Application is due by February 9, 2022. Carter discussed having a special Town Meeting mid to late January with a Public Hearing prior to that meeting vs doing a special election.

Carter noted there are ribbon cutting ceremonies coming up as listed. December 1, 2021 at 8:30 am at Old School Food Pantry at the former Holy Savior School.

Carter noted the reasons for extra costs have been the extended sick time that they have had this year and Covid sick time Officer Replacement. He also noted one Officer is at the academy. Carter stated they are working on ways to cover the costs but the Town could possibly have to go back to the citizens to vote on extending the budget. Brennick questioned if some of the monies that came in for Covid relief could be used and Carter noted that was a possibility. Carter discussed budget items including Utility, Solid Waste, summer roads, Insurances, Bonds, and Social Security.

Chase discussed County Budget and cost of Jail. Chase noted Casino money has helped offset the budget.
