Town Manager Carter stated that Rumford had a low voter turnout but all budgets passed at the same approval rate as when we have a higher voter turnout of 70-80%.

Carter stated the Fire Station is coming along well, footers are nearly completed and the frost walls are being poured. The metal building for bay area is due to be delivered 2^{nd} week of July.

c. Department Heads and Committee Chairs

Public works Director Roberts's states all crosswalks are all painted on Route 2. Raymond Avenue's water line is in and storm line is going in. Porter Ave will be grading and paving after a resident completes his sewer line expected to start July 1st.

CEO Coulombe states he has been working on Vacant Buildings. He has identified 66 buildings. Coulombe discussed erosion on the river bank at Hosmer Field and met with DEP and Army Corps of Engineers.

Coulombe noted a meeting for Community Forest Planning the 2nd Wednesday of the month and local residents are invited. Planning Board is inviting selectpersons to July 12th at 6pm for Comprehensive plan.

Economic Director O'Keefe noted that the new VA Clinic is in regular use. O'Keefe reported that Key Bank closed and that property is for sale. He states he has spoken to developers who have expressed interest.

O'Keefe stated that the Bag Mill Project is moving forward with 33 rooms and some food and beverage options.
