O'Keefe stated that the base rate will be \$600. The base rate of \$600 is based on 1200 cubic feet per water per quarter. If your usage is 1200 cubic feet or below your bill will be \$600 for the year. If the base rate is set at \$600 for the year your remaining sewer bill will be \$150.00 per quarter.

Public Questions: Robert Cameron lives at 358 South Rumford Road: I understand that the prices of everything are going up. I do not have a water that comes to my house. You cannot tell how much water I am using.

O'Keefe did state that if you do not have a connection with the Rumford Water District you get billed the flat rate only. There are provisions in the ordinance looking at private wells. O'Keefe stated that the meter may be required to be able to get an accurate reading.

Lenny Mckenna: How did they determine that 1200 Cubic feet is the minimum.

O'Keefe stated that is based on existing practice and other sewer districts that are run by other towns in the state for municipalities. It is also based on water usage by 1-2 people. O'Keefe stated that the Town will be purchasing Deduct meters for residents to purchase to attach to their outside garden house so if they are watering gardens, pools, washing driveways.

Deb Caudero lives on South Rumford Road. Deb stated that she has lived here for 6 years, and her tax bill has gone up 32%. O'Keefe did say that she would only pay the minimum of \$600.

Jeremy Vashaw asked how many gallons 1200 Cubic feet? O'Keefe stated that is roughly about 8000 gallons.
