The State of Maine has authorized the Town of Rumford to register the following at the Tax Collector's office: ATV's, Snowmobiles, and Boats.

Fees: \$70.00 State Registration Fee  
\$ 5.00 Town Agent Fee  
Sales tax if purchased through a private sale -- 5% of the purchase price  
Paperwork required:  
 Bill of Sale (must include vehicle serial number)  
 Proof of Sales Tax paid (if purchased from a dealer)

 Proof of Sales Tax Paid (if purchased from a dealer)

### STATE REGISTRATION FEE (Includes \$1.00 Agent Fee)

0-10 Horsepower Motor -	\$31.00 with lake and river protection sticker
0-10 Horsepower Motor -	\$16.00 without lake and river protection sticker
11-50 Horsepower Motor -	\$36.00 with lake and river protection sticker
11-50 Horsepower Motor -	\$21.00 without lake and river protection sticker
51-115 Horsepower Motor -	\$42.00 with lake and river protection sticker
51-115 Horsepower Motor -	\$27.00 without lake and river protection sticker
Over 116 Horsepower Motor -	\$50.00 with lake and river protection sticker
Over 116 Horsepower Motor -	\$35.00 without lake and river protection sticker
Personal Watercraft -	\$50.00 with lake and river protection sticker
Personal Watercraft -	\$35.00 without lake and river protection sticker

### NEW REGISTRATION

\$2.00 Registration Fee, *in addition to...*  
*Excise tax* – based on year, length of boat and horsepower of motor  
*Sales tax* if purchased through a private sale – 5.5% of the purchase price  
Paperwork required:  
 Bill of Sale (including Maine registration numbers if boat is used)  
 Proof of Maine Sales Tax paid ie: bill of sale or invoice (if purchased from a dealer)

### RE-REGISTRATION

\$1.00 Registration Fee, *in addition to...*  
*Excise tax* – based on year, length of boat and horsepower of motor  
Paperwork required:  
 Old Registration

### DUPLICATE REGISTRATIONS/TRANSFERS

Duplicate Registration - \$2.00  
Duplicate Registration and Stickers - \$3.00, Lake & River Protection Stickers must be purchased again for full price.  
Resident Transfers - \$4.00 Registration Fee, *in addition to* agent fee and difference in excise tax for boats.

### LAKE & RIVER PROTECTION STICKERS

Prevention of milfoil in Maine waterways has become a very high priority for the State of Maine. A new law was passed requiring the display of a special Lake & River Protection Sticker to launch a boat on inland waters. The cost of these stickers are:  
Resident: \$15.00 to be displayed on boats registered in the State of Maine  
Nonresident (Other): \$35.00 to be displayed on boats that are registered outside of the State of Maine
